

## **CLAIM FORM INSTRUCTIONS**

To receive a cash refund, you must submit a Claim Form either in paper or electronically at the Settlement Website at [www.AlignSettlement.com](http://www.AlignSettlement.com).

### **REQUIREMENTS FOR FILING A CLAIM FORM**

To receive your cash refund, please do the following:

1. You must truthfully and accurately complete all required portions of the Claim Form.
2. Sign the Claim Form under penalty of perjury that all information is true and accurate. If you submit a Claim Form electronically, your electronic signature and submission of the form is treated the same as if you signed the form in hard copy.
3. You may submit the Claim Form for:
  - a. Up to two packages of Align® purchased between March 1, 2009 and October 31, 2009. Each package purchased within this time period has a cash refund value of \$15.88; and/or
  - b. One package of Align® purchased between November 1, 2009 and June 6, 2016. This package has a cash refund value of \$17.50.
  - c. The maximum cash refund amount you may receive is \$49.26.
4. You have two options to complete and submit a Claim Form:
  - a. **Submit the Claim Form electronically through the Settlement Website, located at [www.AlignSettlement.com](http://www.AlignSettlement.com).** Upon completion of the online Claim Form, you will receive an acknowledgement that your claim has been submitted. If you submit a Claim Form electronically, your electronic signature and submission of the form shall conform to the requirements of the federal Electronic Signatures Act, 15 U.S.C. § 7001, et seq. and have the same force and effect as if you signed the form in hard copy.
  - b. You may **MAIL** the completed and signed Claim Form by First Class U.S. Mail, postage prepaid, **postmarked no later than May 16, 2018**, to:

5. Make sure you submit your claim before the Claim Deadline **May 16, 2018** otherwise you will lose your right to receive a cash refund in this Settlement. So that you will have a record of the date of your mailing of the Claim Form and its receipt by the Settlement Administrator, you are advised to use (but are not required to use) certified mail, return receipt requested.
